The cost is reduced to \$250 for the grandchildren of Henry and Lillie Jaeger and their spouse, and waived for the children of Henry and Lillie Jaeger and their spouse. The cost of interring cremated ashes in the designated cremation area is set at \$250. No burial

plot may be reserved until the reservation price is paid in full to the Jaeger Witte Heritage Cemetery Association.
